To qualify for nomination:

1. You must be a fully paid up member of The Wildlife Trust of South and West Wales (WTSWW)
2. You are legally eligible to stand as a Trustee. You must not act as a Trustee if you are disqualified under the Charities Act and subsequent amendments, or disqualified by discretion of the Charity Commission, including if you: a) have an unspent conviction for an offence involving dishonesty or deception (such as fraud); b) are bankrupt or have entered into a formal arrangement (eg an individual voluntary arrangement) with a creditor; c) have been removed as a company director or charity trustee because of wrongdoing including safeguarding matters.
3. Application forms must be signed by a proposer who must be a fully paid up member of WTSWW.
4. You must give details of two people to provide references for you. Your appointment will be subject to satisfactory references being provided.
5. You agree to abide by our Values and Code of Conduct.
6. Your completed form must be received by **Monday 26th September 2022**
